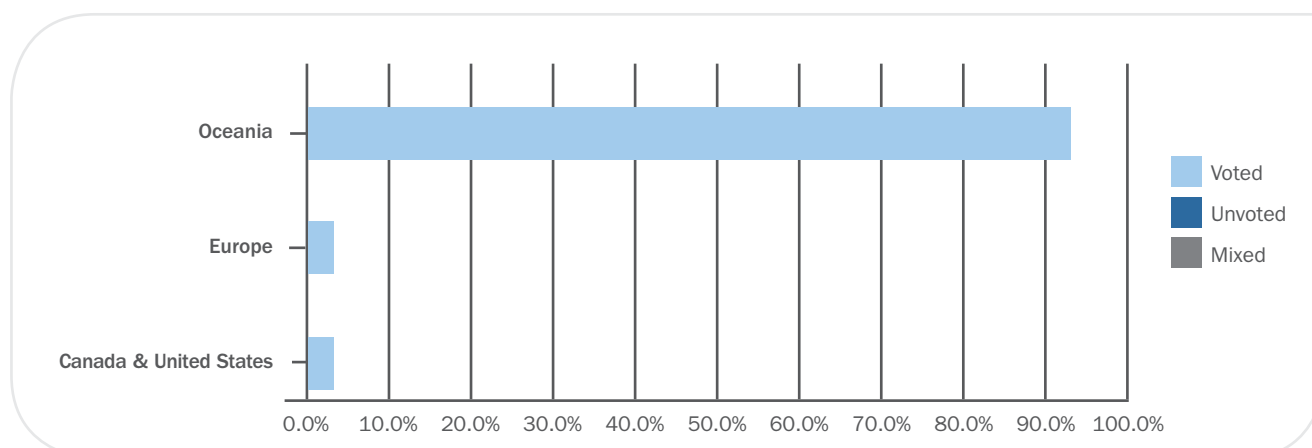

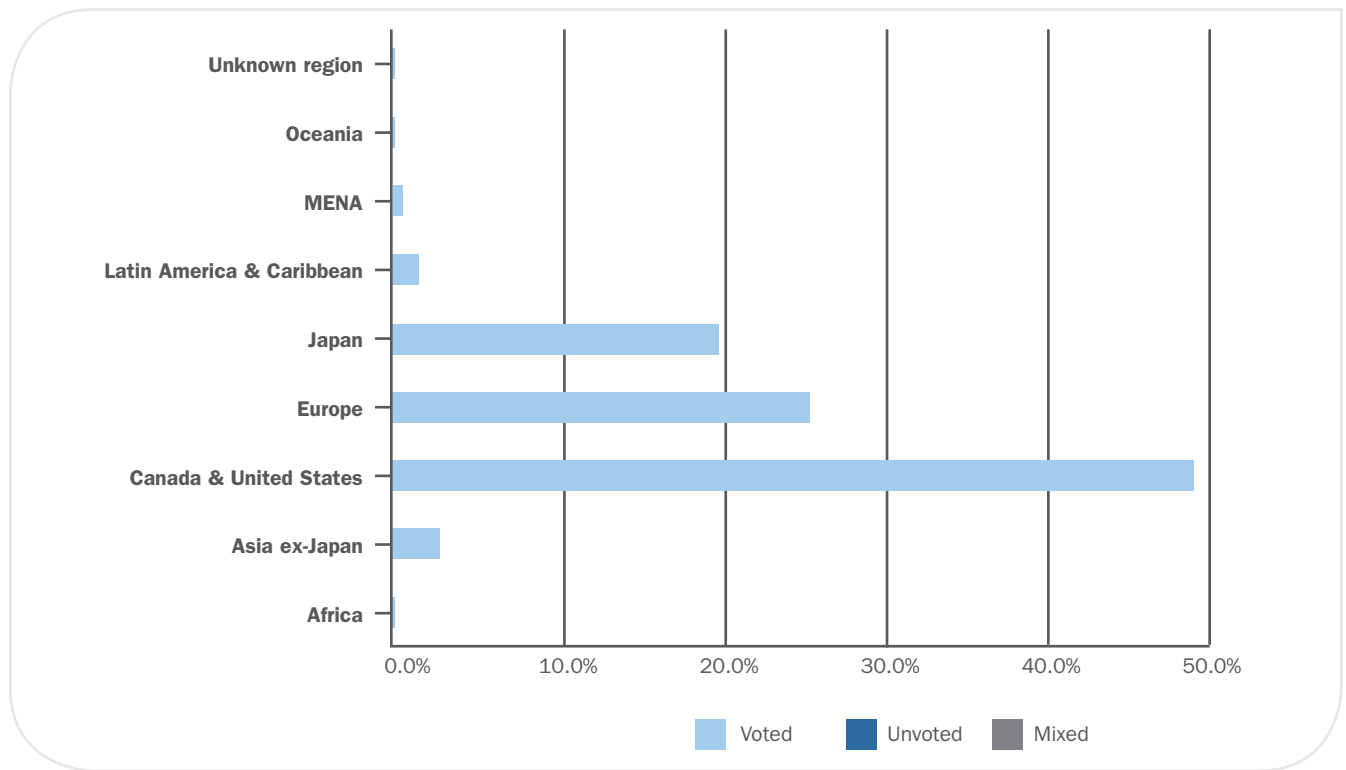

Mandated investments: investments made by or through investment management agreements between managers and the trustee.

Proposal category type	Descriptions
Audit/financials	Auditor-related proposals (e.g. appointment of auditors, ratification of auditor's act) and financial related proposals (e.g. financial statements, allocation of profits/dividends)
Board related	Proposals of board-related issues (e.g. election of directors, board size, related party transactions)
Capital management	Proposals in relation to company's capital management
Changes to company statutes	Proposals in relation to amendments, adoptions and renewals to articles of company's constitutions
Compensation	Proposals related to remuneration of directors (e.g. remuneration policy, director fees, incentive plans)
Mergers & acquisitions	Proposals related to mergers/acquisitions (e.g. restructuring, reorganisation)
Meeting administration	Items related to meeting administration (e.g. authorisation of legal formalities)
Other	Other proposals not included above (e.g. approval of political/charitable donations)
SHP	Shareholder's proposal
